Each infringement can be fined and is very expensive, so WSBC wanted any postings with possible infringements on copyright laws to be taken down on the Western Mass Intergroup (WMI) site.

In looking over the flyers put on the Events section, there were many flyers that may have infringements. WMI had no way of contacting every group, so it was decided to disable the Events tab and are planning to remove all the flyers to be safe. If you have a flyer that needs to be put back up, all images or copied material needs to be removed from the flyer and resubmitted. Any flyers with images will not be accepted on the WMI website. Just a reminder that all OA Conference-approved or Board-approved literature is copyrighted by Overeaters Anonymous, Inc. If you go to oa.org and search copyright requests, there is information to help you find out if you need written permission to use any part of the literature. There is also a copyright permission form if you want to use any part of OA literature.
