## Standing Committee Reports

- **PIPO:** Ann reported that they distributed pamphlets to libraries & health centers. The committee is working on "spreading the word".
- **Phone Liaison:** Carol reported that she had 3 calls this past month & the position is still open.
- **Donate Button/Website:** Lynn reported that there were 2 donations this month. She also wanted it noted that the visits this month to the website are half of last year's visits during this same time period.
- **Share-A-Thon:** Lynn reminded us that the "Shar-a-thon" is scheduled for January 3, 2026 at Bethany Assembly of God in Agawam. The committee has topics for the workshops. The next committee meeting is on Saturday March 15<sup>th</sup> @ 10am
- **Retreat:** Anne reported that the flyer and the registration form is on the website. At the present time the fee is \$320/double room and \$400 for a single room for the weekend along with 6 meals. Single rooms are limited.
